## Ymchwil newydd am blant â Gorchmynion Gwarcheidiaeth Arbennig


Er nad yw plant sy'n destun Gorchmynion Gwarcheidiaeth Arbennig yn blant sy'n derbyn gofal, maen nhw'n rhannu llawer o'r un nodweddion â'r boblogaeth sy'n derbyn gofal. Bydd rhai ohonynt yn blant a fu'n derbyn gofal gynt, bydd eraill wedi bod yn agos at dderbyn gofal neu'n dod o deuluoedd sydd mewn argyfwng, a bydd llawer wedi cael profiadau niweidiol yn ystod plentyndod, yn aml yn gysylltiedig â chamdriniaeth ac esgeulustod.

Mae'r cod ymarfer ar gyfer Gorchmynion Gwarcheidiaeth Arbennig yng Nghymru (a gyhoeddwyd o dan adran 145 Deddf Gwasanaethau Cymdeithasol a Llesiant (Cymru) 2014) yn amlygu pwysigrwydd deall a chefnogi addysg plant drwy gydol eu hamser yn yr ysgol. Mae hyn yn cydnabod y gallai profiadau cynnar plant darfu ar eu haddysg neu ei rhwystro.

Mae tîm ym Mhrifysgol Caerdydd yn ceisio helpu i wella canlyniadau addysgol ar gyfer plant ysgol gynradd sy'n destun Gorchmynion Gwarcheidiaeth Arbennig, trwy eu gwahodd nhw a'u gwarcheidwaid arbennig i'r brifysgol i gymryd rhan mewn ymchwil yn yr uned Asesu Niwroddatblygiadol. Yno, bydd y plant yn cymryd rhan mewn gweithgareddau i brofi eu sgiliau gwybyddol, datblygiadol, a gweithredu emosiynol. Bydd seicolegydd addysg yn trosi'r canlyniadau hyn yn adroddiad ar gyfer athro'r plentyn gydag ymyriadau awgrymedig i weithio gyda'r plentyn.

Gall athrawon wneud yr atgyfeiriad ar gyfer y plentyn gyda chaniatâd y gofalwr. I fod yn gymwys ar gyfer yr astudiaeth, bydd angen i blentyn fod rhwng 4 a 7 oed a bod yn destun Gorchmynion Gwarcheidiaeth Arbennig. **Nid oes angen iddo fod wedi cael unrhyw anawsterau blaenorol na diagnosis.**

## **The SHRN 2024 data collection in primary schools is now open**

This is a reminder for those primary schools who registered to take part in SHRN data collection this autumn term that they will need to input the following information into their SHRN dashboards by the end of the Autumn term:

- Total number of learners in each year group (years 3-6)
- Number of parental and carer opt-outs received
- We require this information in order to calculate response rates at your school.

We encourage schools to survey as many learners as possible across all year groups, to give them the best data possible to inform action planning at their school. The School Environment Questionnaire (SEQ) can be completed by a member of the school's leadership team (SLT) (or representative). This survey helps understanding of effective policy and practices and can be used to evidence progress for the Whole School Approach.

**The release of School SHRN Data Reports can be expected for Easter 2025.**

A recent study found that girls and women are less likely to engage in regular physical activity than boys and men across Wales. But what role does menstruation play in this?



## **New research about children with Special Guardianship Orders (SGOs)**


Children subject to Special Guardianship Orders, although not looked after children, share many of the same characteristics as the looked after population. Some will be former looked after children, others will have been on the edge of care or come from families in crisis, and many will have experienced adverse childhood experiences, often related to abuse or neglect.

The code of practice for Special Guardianship Orders in Wales (issued under section 145 of the Social Services and Well-being (Wales) Act 2014) highlights the importance of understanding and supporting children's education throughout their time at school. This recognises that children might have disruptions or barriers to their education due to their early experiences.

A team at Cardiff University are trying to help improve educational outcomes for primary school children on SGOs, by inviting them and their Special Guardians to the university to take part in research at the Neurodevelopmental Assessment unit. There children will engage in activities to test their cognitive, developmental, and emotional functioning skills. An educational psychologist will translate these results into a report for the child's teacher with suggested interventions to work with the child.

Teachers can make the referral for the child with the carer's permission. To be eligible for the study a child needs to be 4-7 years old and have a Special Guardianship Order. **They do not need to have had any prior difficulties or have a diagnosis.**
